The editor reserves the sole right to reject any manuscript and return it to the author for revision based on format, style, or editing.

Article should be submitted in a format conducive to blind review. The author's name and identifying information should only be listed in a detachable cover page. Once an article is accepted for publication, corrections, additions, or substantive revisions (other than for grammar, spelling errors, and dates) are prohibited. Copyright on materials published in the Journal are held by the American Association of Brief & Strategic Therapies (AABST). Reprints or permission to reproduce copyrighted material must be obtained in advance from the AABST.
